1. Dangerous Goods (DG) shipments (IMDG, IATA, ADR) are not handled outside warehouse working hours or on weekends.
2. Services are available from 09:00 to 17:00, Monday to Sunday (excluding customs-related services).
3. Forklift and cargo loader bookings must be confirmed at least 48 hours in advance.
4. A double charge applies for handling performed on national or bank holidays, or outside standard working hours.
5. Hourly rates are charged for each started hour.
6. Scrapping of rotable parts includes a scrap certificate. Reports for chemical or consumable disposal are available upon request.
7. Availability of other services must be confirmed in advance.
8. Storage services are subject to space availability and warehouse confirmation.
9. All prices are listed in EUR and exclude VAT, customs duties, and any third-party charges unless stated otherwise. Prices are indicative and may be updated without prior notice. The latest valid version of this price list is always available on request or at [www.jobair.eu](http://www.jobair.eu).
10. The listed services apply to standard operations under regular working conditions at JOB AIR Technic facilities. Special handling, oversized cargo, or urgent (AOG) support may require prior coordination and individual quotation.
